## VETERAN STATUS/ELIGIBILITY

### **Minimum Eligibility:**

- Enlisted after September 7, 1980 **or**
- Entered active duty after October 16, 1981

**AND**

- Must have served 24 consecutive months (or full period for which they were called to active duty)
  - ◇ Minimum duty requirement may not apply to those who were discharged for a disability incurred or aggravated in the line of duty, for a hardship or “early out” or those served prior to September 7, 1980

### **Enhanced Eligibility**

- Former Prisoner of War
- Receipt of Purple Heart Medal/Medal of Honor
- Have a compensable VA awarded service connected disability of 10% or more
- Receipt of VA Pension
- Discharged from the military because of a disability (not preexisting), early out or hardship
- Served in a Theater of Operations for 5 years post discharge
- Served in the Republic of Vietnam from January 9, 1962 to May 7, 1975
- Served in the Persian Gulf from August 2, 1990-November 11, 1998
- Stationed or resided at Camp Lejeune for 30 days or more between January 1, 1957 and December 31, 1987
- Found by VA to be Catastrophically Disabled
- Previous years' household income is below VA's national Income or Geographical- Adjusted thresholds
